 retraining and refresher courses (ICAO Requirement)
 - Maintain effective relationships with relevant organisations such as ICAO, WMO, ACSA, regulators, airlines (BARSA, AASA, etc) and other internal and external stakeholders to deliver on the mandate of the department.
 - Liaise with other aviation regulatory bodies viz. SACAA to promote the SAWS' Aviation services to enhance air navigation safety.
 - Represent SAWS in local and international aviation services/ product forums
 - Ensure SAWS' participation in the outreach programmes e.g., the air show, exhibitions, National safety events etc.
